1. All animals must have 2 official eartags & correct passport on arrival. **NB ~ PASSPORTS MUST CORRESPOND WITH THE EARTAGS ON ANIMALS PRESENTED ~ FAILURE TO MATCH WILL RESULT IN CARCASE BEING CONDEMNED.**
2. All cattle must be under 30 months of age on date of slaughter.
3. Only animals born, reared & finished in Scotland and have continuous Farm Assurance status from birth are eligible for the 'Scotch Beef' label. Animals with English & Welsh passports are classified as British.
4. All consignors must be members of an Approved Organic and Farm Assurance scheme, valid copies of organic registration must be held by McIntosh Donald.
5. Animals must be on final producers holding for a minimum of 20 days and have no more than 4 moves (5<sup>th</sup> move from farm to abattoir).
6. No illegal substances or feed containing ingredients of animal origin have been used in the rearing or finishing of these cattle and all medicinal withdrawal periods have been observed. No Digestive enhancers have been fed to these animals.
7. Animals MHS cleanliness grade 3 or over will not be despatched for slaughter.
8. All hauliers used must be members of the **Farm Assured Hauliers Scheme.**
